

REGISTRATION GUIDE

Candidates who have the right to enroll in the university must submit the necessary documents for registration between the dates specified in the acceptance letter,

- They apply to the International Student Center in person and make their final registration.
- In cases where it is not possible to apply in person, the registration of the candidate whose excuse is accepted by the relevant unit is made online.
- For those under the age of 18, a Letter of Consent is required to register.
- **Online registration: After** pre-registration, the original documents of the candidate are submitted in person, and it will be done in two stages, returning to the final registration.
 - ◆ Pre-registration, yosyerlesme.sakarya.edu.tr. It will be done online on the page. Candidates who do not / cannot upload the documents required for registration to the system on the registration dates and upload incomplete documents will not be pre-registered. These candidates will be deemed to have lost their registration rights.
 - ◆ **Candidates who have pre-registered; Final** registration will be made if the originals of the required documents are submitted to the International Student Center in person before the **course registration dates determined by the university in the general academic calendar.**
 - ◆ Students are required to prove that they have made the online registration to the University during the legal period of stay in Turkey at the stage of converting their pre-registration into final registration. Students who cannot submit the relevant documents, do not have the right to stay legally in Turkey or violate the legal stay period will not be registered even if they are pre-registered.

❖ **Those who do not have the right to stay legally in Turkey cannot enroll in a university.** The status of the candidates regarding whether they have the right to stay legally in Turkey (visa/residence permit) is evaluated within the scope of the provisions of the legislation determined by the relevant Ministries and the Presidency of Migration Management. **The registrations of the candidates who are determined not to have the right to stay legally in Turkey will be deleted, and no refund will be made to the candidates in question.**

❖ As a result of the control to be made through the YÖKSİS system, at another University in Turkey. Students who are understood to be registered at the same program level will not be registered.

❖ Applicants who wish to register are required to pay their tuition fees.

❖ **After registration, students who are found not to comply with the application requirements, apply with misleading information and documents, and have errors in their information and documents are dismissed from the university. Candidates in this situation and students who deposit money for online pre-registration, do not make final registration or register and cancel their registration voluntarily will not be refunded.**

Acceptance letter,

- ❖ For candidates who are placed in one of their preferences as a result of the application, the acceptance letter is created through the international student preference system. You can obtain your acceptance letter **by** logging in with your username and password from the international student preference system yosyerlesme.sakarya.edu.tr.
- ❖ Candidates who are admitted to our university are required to obtain a "student visa" from the consulates/embassies with the "acceptance letter" they receive from the application system. **Embassies and**

The information form must be filled in completely and accurately and signed and submitted to the authorized person with other documents during registration.

- 1. Acceptance letter printout:** Candidates admitted to our university are required to obtain a "student visa" from the consulates/embassies by obtaining an "acceptance letter" from the application system. **Embassies and Consulates can verify acceptance letters with the "Acceptance Letter Number". Acceptance letters are not sent to candidates, embassies, consulates and intermediary organizations.**
- 2. Diploma/Graduation Certificate:** The original of the high school (Secondary Education) diploma/graduation certificate and its Turkish translation approved by the Foreign Representatives of the Republic of Turkey or the Notary Offices of the Republic of Turkey.
- 3. - Transcript:** The original transcript and its Turkish translation approved by the Foreign Representatives of the Republic of Turkey or the Notary Publics of the Republic of Turkey. *(Except for candidates who have a diploma issued by the Ministry of National Education of the Republic of Turkey and candidates whose high school success average is included in their diplomas ,)*
- 4. - Identity Document/Passport:** **The original of the** Republic of Turkey Identity Card/Residence Permit Document/Blue Card/Temporary Protection Identity Document/International/Protection Status Holder Identity Document. **For candidates who do not have an Identity Document,** the original passport and its Turkish translation approved by the Foreign Representatives of the Republic of Turkey or the Notary Publics of the Republic of Turkey.
- 5. -4 4.5x6cm photographs.**
- 6. Exam Result document printout** (University entrance exam result document used in application to our university)
 - -Checks will be made on the TR-YÖS** Result verification page.
 - Candidates who apply with the SAT Result and are placed will be asked to confirm their exam results on the SAT College Board official website with their usernames and passwords during registration, if their original documents do not come from the College Board until registration. **Candidates who cannot provide this will have their registration rights canceled.**
 - -Candidates who apply and settle with the ACT Result will be asked to confirm their exam results on the ACT official website with their usernames and passwords during registration. Candidates who cannot provide this will have their registration rights canceled.
 - -Candidates who apply with **GCE A Level and IGCSE** documents must bring their approved Certificates and will be asked to confirm their exam results on the official website with their username



and password during registration. In addition, the grades declared by the candidates in question during the application process must be exactly the same. Otherwise, the registration rights of the relevant candidates will be canceled.

- **-Candidates who apply and settle with the WAEC Result must have their WAEC exam entrance card with them during registration.**

7. Certified Family Population Registration Sample: For candidates with dual citizenship, the original of the document to be obtained from the Population Directorates of the Republic of Turkey, where the first nationality is clearly stated.

8. Blue Card Population Registration Sample: The original of the document to be obtained from the Population Directorates of the Republic of Turkey, which includes the explanation showing the registry information from the candidates who have a Blue Card.

9. Dormitory Entry and Exit Document: For candidates who are citizens of the Republic of Turkey and have completed their entire high school education abroad (except TRNC), the original of the document to be obtained from the e-government or Police Directorates, issued to cover the start and end dates of High School (Secondary Education).

10. Equivalence Certificate (if any) The original of the document to be obtained from the Overseas Representatives of the Republic of Turkey or the Provincial Directorates of National Education of the Ministry of National Education of the Republic of Turkey from the candidates who are citizens of the Republic of Turkey and have completed their entire high school education abroad (except TRNC). **It is not mandatory during registration.**

11. Consent letter (Parental permission/consent document): For candidates under the age of 18 **as of the date of registration**, the original of the document to be obtained from the official authorities and its Turkish translation approved by the Foreign Representatives of the Republic of Turkey or the Notary Publics of the Republic of Turkey.

(7) Turkish Proficiency Certificate (if any) (Documents of Centers without Exam Result

Verification page will not be accepted.) Those who do not have a language proficiency certificate are directed to Sakarya TÖMER Language training center.

a) **Those who bring a license** B2 level certificate; He chooses a course and starts his education. They will be obliged to improve their Turkish. These candidates are obliged to increase their Turkish level to C1 in order to take courses from the next class at the end of 4 semesters, students who do not fulfill the C1 proficiency requirement are required to take 5. Semester (3. They cannot take lessons from the class.

b) Associate Degree Students (2 years) Start their **associate degree** education with B2. Students are obliged to increase their Turkish level to C1 until their graduation. Students who do not fulfill the C1 proficiency requirement cannot graduate.

c) Students who bring a C1 level certificate start their education and fulfill the Turkish language requirement until they graduate.

Note: Students in undergraduate programs whose medium of instruction is a foreign language should receive A2 at the beginning of the third semester; and a B1 level Turkish Proficiency certificate is required upon graduation.

Important Notes: After your registration, you must first apply for residence. In the application, your residence permit period is determined according to the duration of your passport and health insurance. It will be more useful for you to have a passport for at least 5 years in terms of residence. **Click for residence information !!**

❖ If it is determined that the information and documents declared by the candidate during the application and/or registration are untrue, his/her registration will be deleted and all student rights will be canceled.
