



# **DOCUMENTS REQUIRED FOR REGISTRATION**

The information form must be filled in with complete and correct information and submitted to the authorized person with other documents during registration.

- ✓ Registrations will be made in person at the International Student Center.
- ✓ (Those who will register with a power of attorney must have an Apostille Annotation made on the power of attorney they have received from their country or have it approved by the Turkish Consulates. Registration will not be made with an unapproved power of attorney.)
- ✓ Consent is required for those under the age of 18 to register.
- (1) Original High School Diploma and Turkish Translation approved by the Turkish Embassy or Consulate in their country.
- (2) Candidates who are Turkish nationals or dual nationals are required to submit a document showing that they have completed all of their high school education in a foreign country (other than Turkey or TRNC) from the institution where they are studying, and an overseas entry-exit document covering the period of their high school education.
- (3) "Equivalency Certificate" showing that the high school diplomas of the candidates are equivalent to the diplomas obtained from Turkish high schools and to be obtained from the Ministry of National Education of the Republic of Turkey or the Turkish Embassy in their country.
- (4) The original of the Transcript and its Turkish Translation approved by the Turkish Embassy or Consulate (Apostille) in their country.
- (5)- Printout of the Exam Result Document
- - Checks will be made on the TR-YÖS Result verification page.
- Candidates who apply with the SAT Result and are placed will be asked to confirm their exam results on the official website of the SAT College Board with their username and password during registration, if their original documents do not come from the College Board until the registration. Candidates who fail to do so will have their registration rights revoked.
- - Candidates who apply and are placed with the ACT Result will be asked to confirm their exam results on the ACT official website with their usernames and passwords during registration. Candidates who fail to do so will have their registration rights revoked.
- -Candidates applying with GCE A Level and IGCSE documents must bring their approved Certificates and will be asked to confirm their exam results on the official website with their username and password during registration. In addition, the grades declared by the candidates during the application process must be exactly the same. Otherwise, the registration rights of the relevant candidates will be canceled.
- -Candidates who apply and are placed with their WAEC Result must have their WAEC exam entrance































## card with them during registration.

**(6)** Turkish Proficiency Certificate (Documents of Centers that do not have an Exam Result Verification page will not be accepted.)

### (7) It will be checked whether foreign students have legal residence in Turkey.

- The student's entry date to Turkey will be checked, and those whose visa exemption has expired will not be registered.
- Visa exemption periods are applied differently for each country.
- Students can learn the duration of their country from the consulates, the internet or the Provincial Migration Administration.
- After your registration, you must first apply for residency. In the application, your residence permit duration is determined according to the duration of your passport and health insurance. It will be more beneficial for you to have your passport for at least 5 years in terms of residence. Click here for residency information!!
